Bennington County Regional Commission ("BCRC") submitted a preapplication to the Land Use Review Board ("Board") for review pursuant to 24 V.S.A. § 4348(b). The Board deemed the preapplication complete on May 8, 2026, and issued a notice of the site visit and the public meeting on May 14, 2026. The May 14, 2026, notice contained incorrect information, and the Board is now reissuing this Corrected Preapplication Site Visit and Meeting Notice.
